Enter through Gate 1, near light tower 5. Take lift/escalator to level 2 If you are coming to the ground by-

CAR: Enter via Entrance A off Brunton Avenue. The Security Officer will direct you to park in the Northern Stand. Park closest to lifts 1,2 & 3 and take lift to level 2, OR: Park at Melbourne & Olympic Park, northern carpark. Enter car park from Swan St (Entry D), walk across footbridge (blue) to the MCG. At the end of the foot bridge you will see light tower 5. Head to your left, you will see Gate 1, enter here

RICHMOND STATION: Exit station and cross Punt rd. Walk toward the MCG, along Brunton Ave, you will see some stairs, go up the stairs towards light tower 4, walk around the concourse to light tower 5, just a little further around you will see Gate 1, enter here

JOLIMONT STATION/TRAM FROM WELLINGTON PRDE: Exit station and head through the park towards the MCG (light tower 1) veer to the right and head to the temporary wooden fence, to find the concrete path, follow the path to the right, head toward light tower 6, up the ramp and head towards the ground just a little further around you will see Gate1 enter here

TRAM FROM VODAFONE ARENA: Get off the tram at Vodafone Arena stop. Take the stairs/lift to the next level, walk across footbridge (blue) to the MCG. At the end of the end of the footbridge you will see light tower 4. Head left around the concourse to light tower 5, just a little further around you will see Gate 1, enter here.

TAXI: Ask the cab driver to drop you off at the corner of Jolimont Terrace and Wellington Pde, head down Jolimont Terrace toward light tower 5, walk up the ramp as if heading for Rod Laver Arena, just before the railway tracks on the left is Gate 1, enter here.

JAMES SUTHERLAND, Chief Executive Officer, Cricket Australia joined the Australian Cricket Board (as it was known then) in 1998, becoming CEO three years later. He has helped guide the organisation through a detailed strategic review, which has given it and its member State Cricket Associations a clear, tangible understanding of what Australian cricket needs to do if it's to continue to be Australia's favourite sport. James' role involves a close relationship with the International Cricket Council via the ICC's Chief Executive Committee, of which he is a member. James was educated at Melbourne University and qualified as a chartered accountant, working for Ernst and Young before marrying his profession with his personal passion, moving into sports management in a senior finance role at the Carlton Football Club.

WILLIAM (BILL) LYTTON, Former Executive Vice President and Chief Legal Officer, Tyco International Ltd served as Chief Compliance Officer and led the global law department of almost 200 lawyers. Bill joined Tyco after a distinguished career in both legal practice and the corporate sector. In 1987, he served as Deputy Special Counsellor to President Reagan, coordinating the White House response to the congressional inquiries and independent counsel's investigation of the Iran-Contra matter. He continued as a consultant to the President throughout the Reagan Administration. He also served as Special Counsel to George H.W. Bush on issues relating to the Iran-Contra matter.

SAUL ESLAKE, Chief Economist, ANZ Banking Group is a member of ANZ's Group Asset and Liability Committee, which oversees the management of the Bank's balance sheet, and is also Chairman of ANZCover, the Bank's internal fraud, crime and professional indemnity insurer. Saul is currently a member of three Federal Government advisory panels — the Tourism Forecasting Committee, the Trade Policy Advisory Council, and the Foreign Affairs Council — and of the Premier of Victoria's Business Advisory Network.

RICK AARONS, Corporate Patent Counsel, CSIRO Legal. Rick is a lawyer and patent attorney and provides IP specialist involvement in major transactions, has responsibility for improving IP management systems across the organisation, and works on IP dispute management and IP policy development. ELECTRONIC DISCOVERY WITHOUT THE PANIC BUTTON

What impact would major litigation or a regulatory investigation have on your organisation? Would it cause a panic that consumed inordinate time and resources? Recent cases indicate that the extensive search of corporate electronic records is likely to be a requirement in litigation or regulatory investigation matters. Australian courts are increasing their focus on electronic discovery obligations and recent international cases have demonstrated that organisations can receive significant fines or adverse rulings for not meeting their obligations.

A reactive approach to electronic discovery can be a time consuming, expensive and often frustrating process. A small investment of time now can reduce risk and save costs later; the time to plan and prepare is beforehand. This workshop will address the key electronic discovery challenges faced by businesses today and some practical strategies that legal counsel can use to anticipate these challenges.
