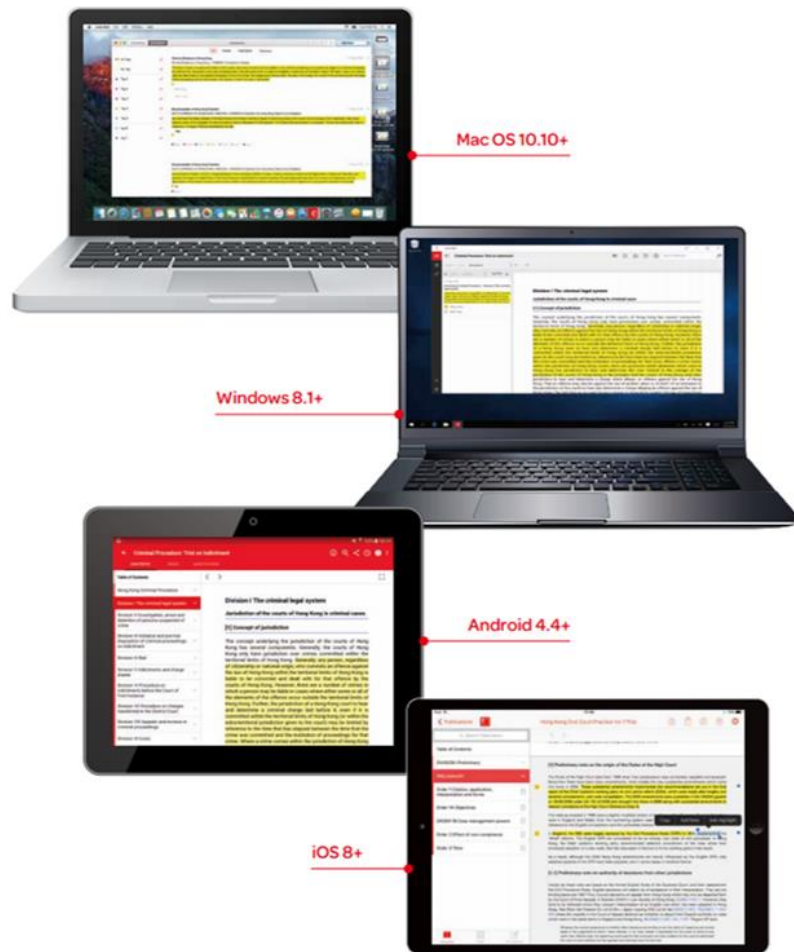
## Device Compatibility

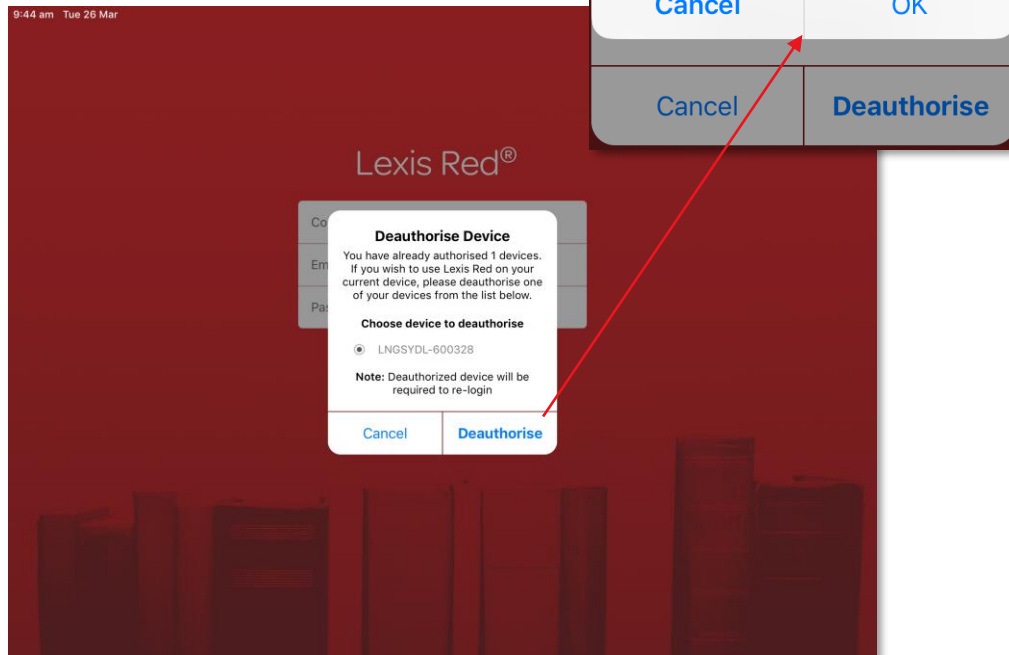
# Lexis Red 3.10

## Screenshots

### Login screen

- Switch registered device authorisations
  - *Addresses problem*: user cannot access Lexis Red when they get a new tablet or computer, due to the 2-device limit having been reached for their account.

*Note*: images taken from iPad but the feature is supported on each OS.



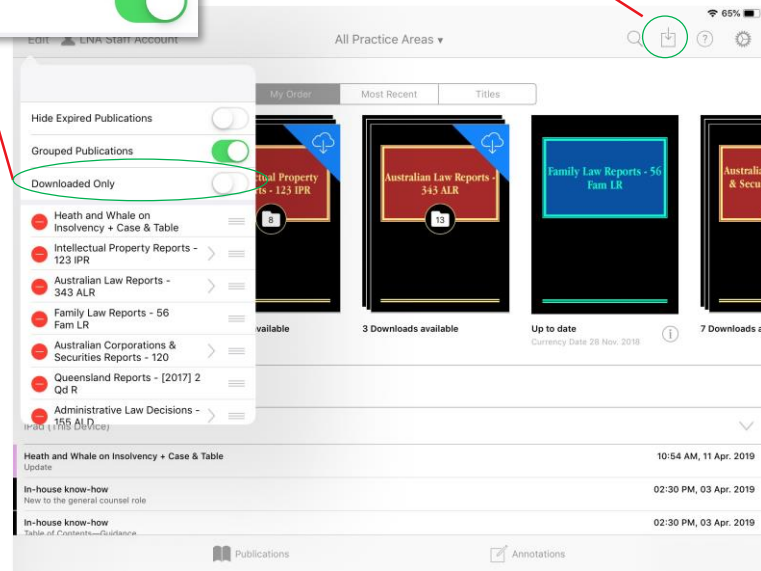
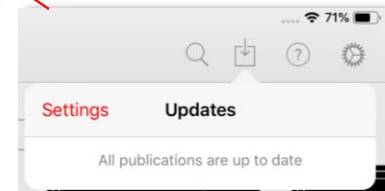
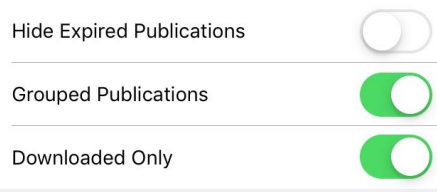
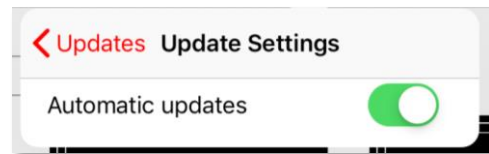
# Lexis Red 3.10

## Screenshots

### Publications screen

- Filter publications to show downloaded titles only
  - *Use case:* after downloading publications, the user wants to see those titles instead of their full Lexis Red collection.
- Automatic updates turned on by default.
  - *Addresses problem:* user does not know how to download content updates or set up the automatic option.

*Note:* images taken from iPad but the feature is supported on each OS.



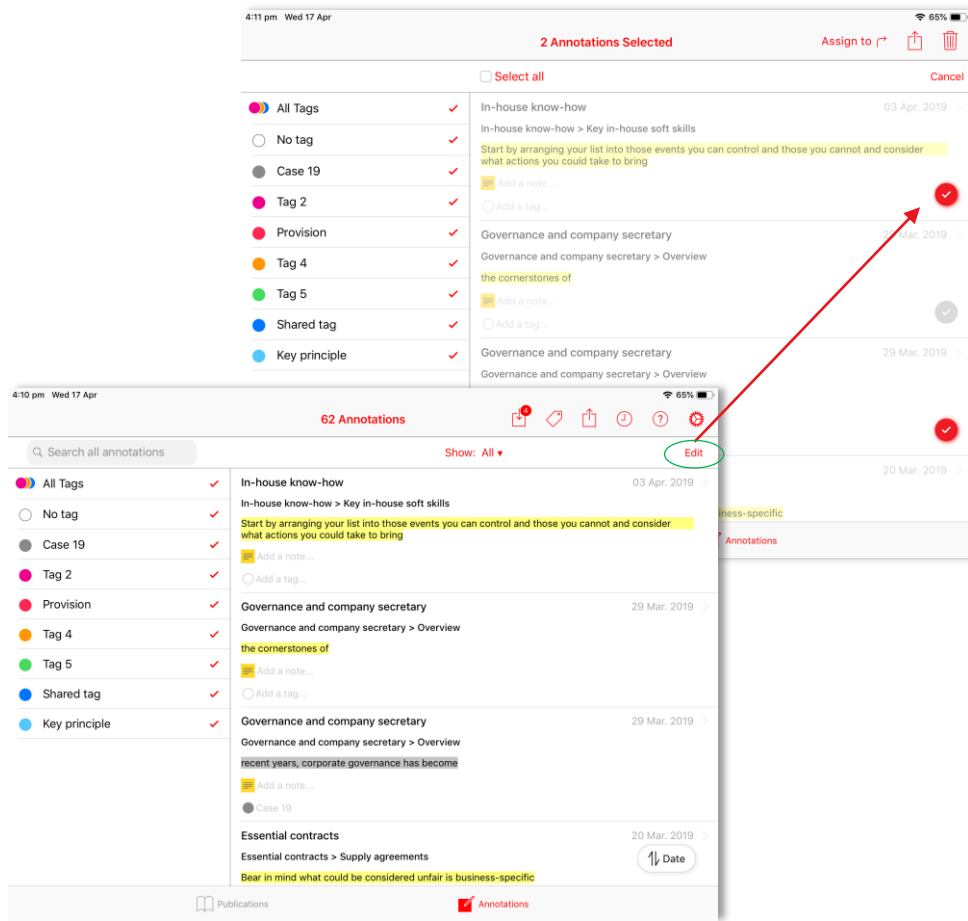

### Annotations screen

- Annotation editing enhancements
  - Addresses problem:* user cannot find the option to select and edit/delete multiple annotations.

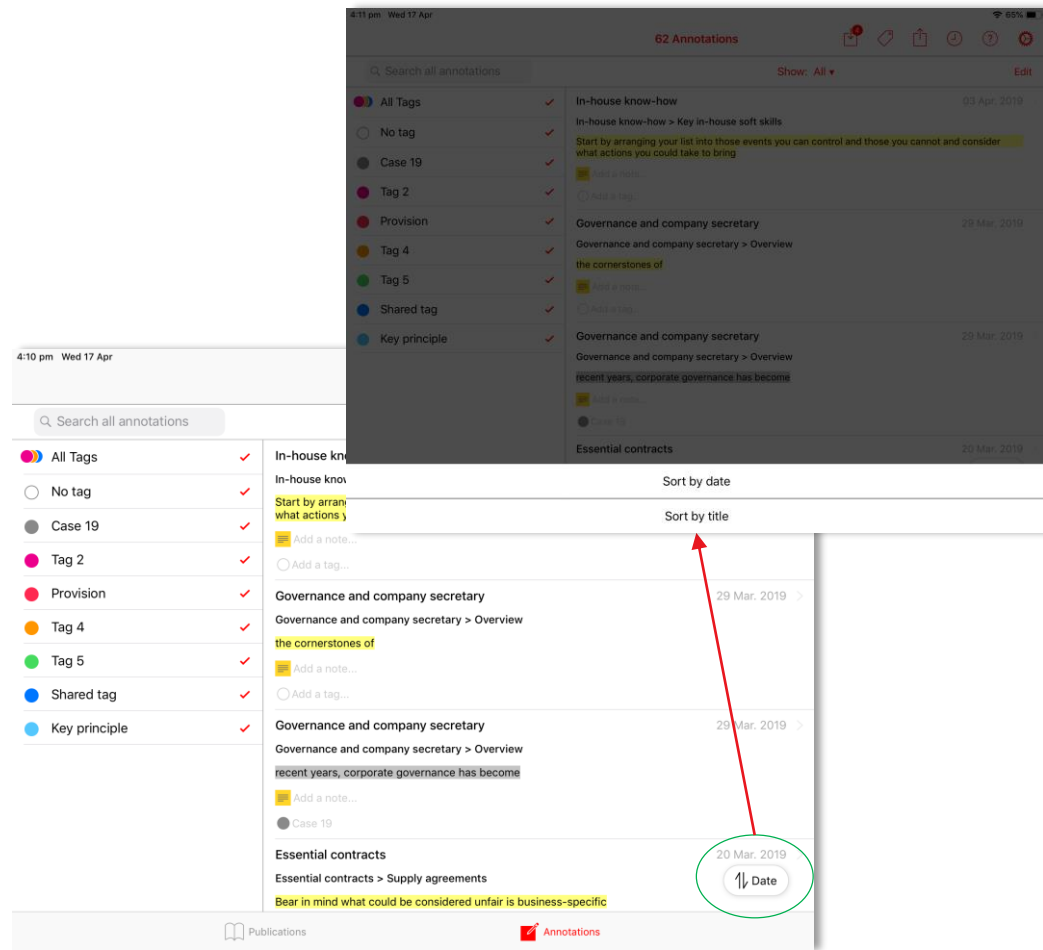

### Annotations screen

- Sort by date or title
  - *Sort by title use case:* user wants to see their annotations for a particular publication.
  - *Sort by date use case:* user wants to see their latest annotations, as they pertain to their current matter/s.

*Note:* images taken from iPad but the feature is supported on each OS.

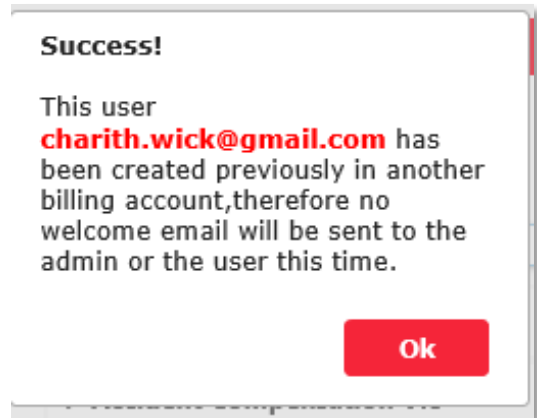


# Lexis Red 3.10

## Screenshots

### Digital Library (Administrator view)

- Reminder for when a newly created user is in another billing account
  - *Addresses problem:* knowledge manager ('KM') expects a welcome email to be generated when creating a new user in their Lexis Red Digital Library (Admin access).  
Relevant when a KM is managing titles for an organisation where some participants also have independent subscriptions (e.g. The KM of a law society is building a lending library for members who also subscribe to Lexis Red as firm or sole practitioners).





# Lexis Red 3.10

## Screenshots

### Digital Library (Administrator view)

- Auto-queuing of loan requests
  - *Use case:* multiple users request to borrow the same title in the Digital Library and the knowledge manager wants to manage the order in which the users receive the loan title, based on urgency.
